I, the undersigned, know that participating in the L'MAX Bike Ride is a potentially hazardous activity, and I participate in it of my own free will and choice. In choosing to participate in the L'MAX Bike Ride and related events, I fully accept and assume all risk including, without limitation, physical injury, mental injury or trauma, death, contact with other participants, equipment failure, inadequate safety equipment, the effects of weather including extreme temperature conditions, traffic, contact with motor vehicles of all types and descriptions, collisions with other riders or fixed objects, the conditions of the road and participating in events along the route, all such risks being known and appreciated by me. I assume the risk of all conditions and potential occurrences during the L'MAX Bike Ride and its related events and waive all specific notice of existence of either. I shall pay my own medical and emergency expenses in the event of accident, illness, or other incapacity regardless of whether I have authorized such expense.

I realize the L'MAX Bike Ride requires physical conditioning and I represent that I am in sound medical condition capable of participating in the ride without risk to myself or others. I have no physical or medical impediment which would endanger myself or others. I understand that a situation may arise during the L'MAX Bike Ride which may be beyond the control of the sponsors, promoters or organizers and agree to ride so as not to endanger myself or others. I agree to be solely responsible for the condition and adequacy of my bicycle, safety gear and riding equipment.

Having read this waiver and knowing these facts and in consideration of my entry acceptance, I, for myself and anyone acting on my behalf, waive and release Culver Lake Fest Committee and L'MAX Bike Ride sponsors and participating clubs, communities and organizations, L'MAX Bike Ride officials, volunteers and their representatives, agents, and successors of all of the above, from any and all claims of any kind I have, may have or may hereafter accrue against the released parties either directly or indirectly, including claims brought by third parties, arising out of or relating in any respect to my attending or participating in the L'MAX Bike Ride, including without limitation, damage or harm to my person or property which may be caused by any act, or failure to act, by the above persons and entities. I further agree to indemnify and hold the parties released above from any and all losses, damages, claims and expenses, including attorney fees, arising from or relating in any respect to my participating in the L'MAX Bike Ride or related events. I further agree to abide by all L'MAX Bike Ride rules and regulations.
